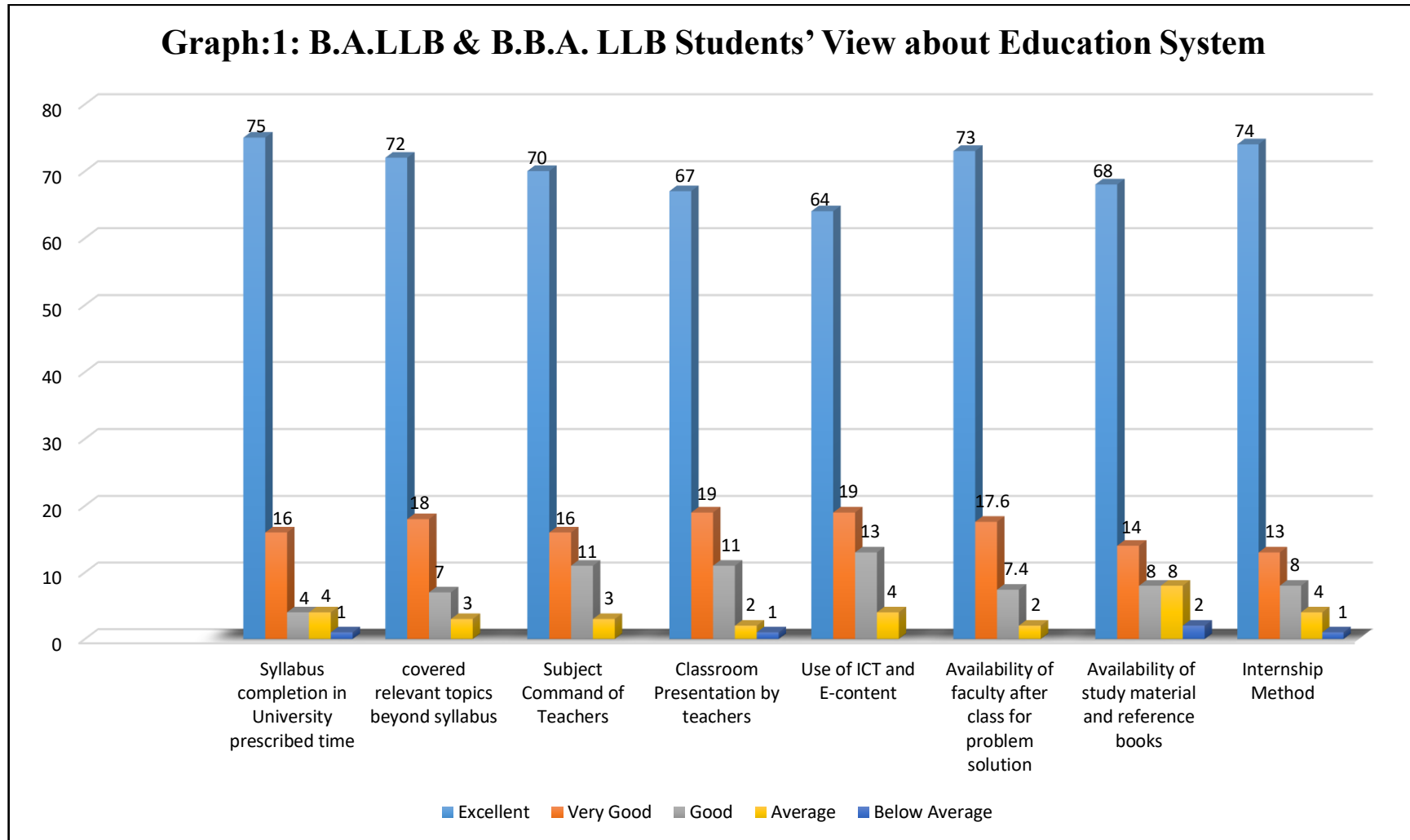

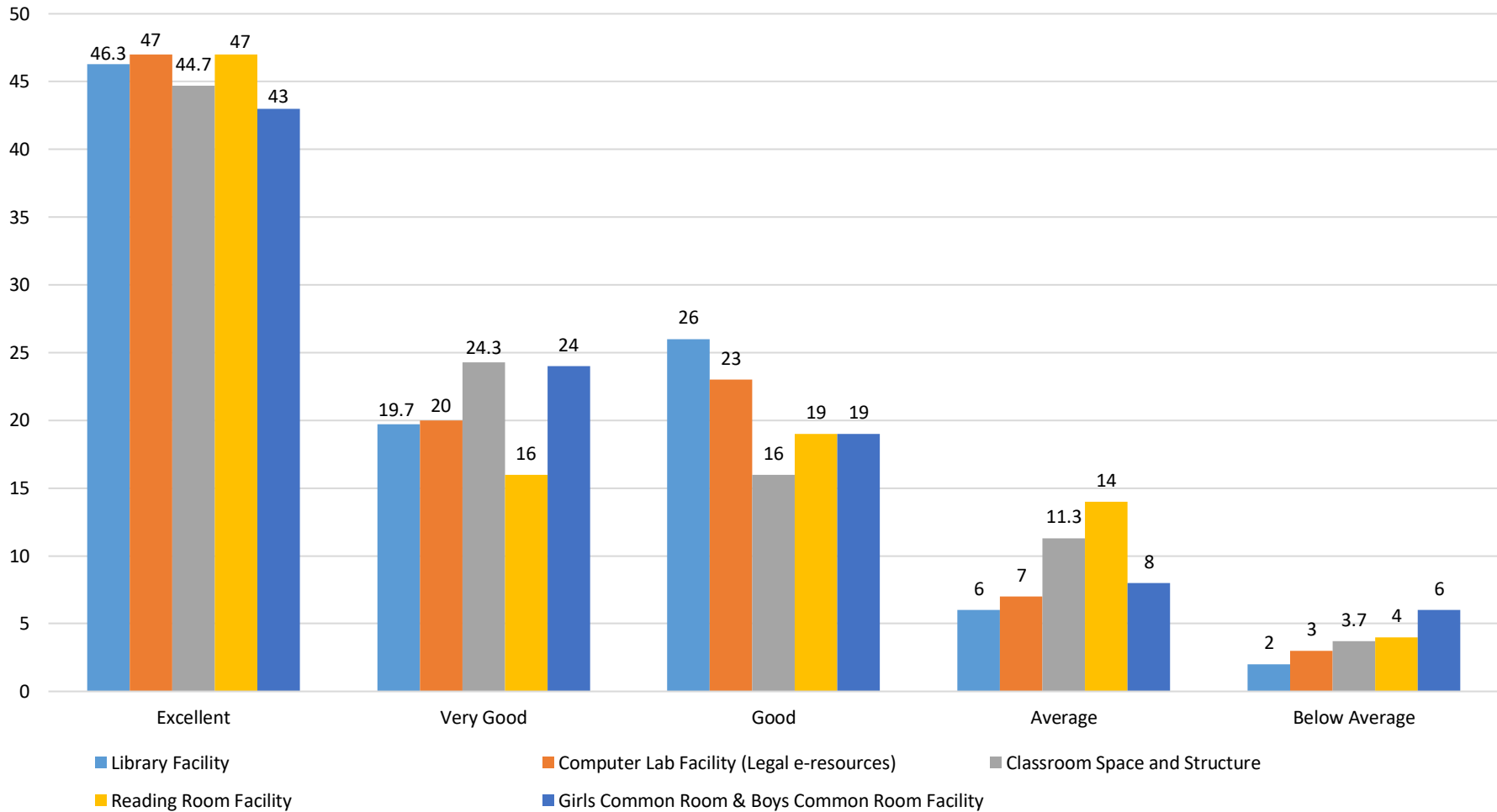

❖ Graphical Analysis of Students' Feedback Response (Academic Year 2017-2018)



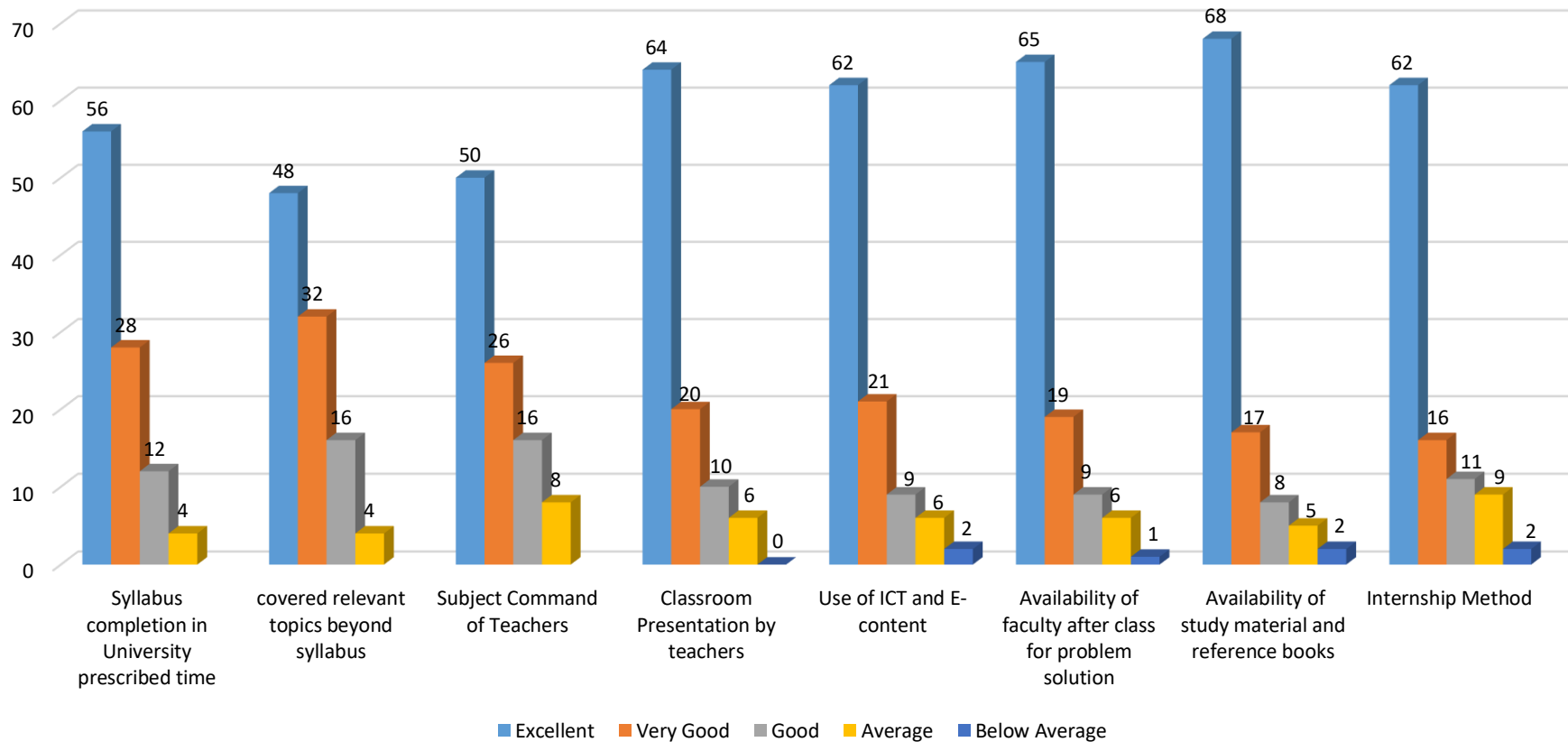

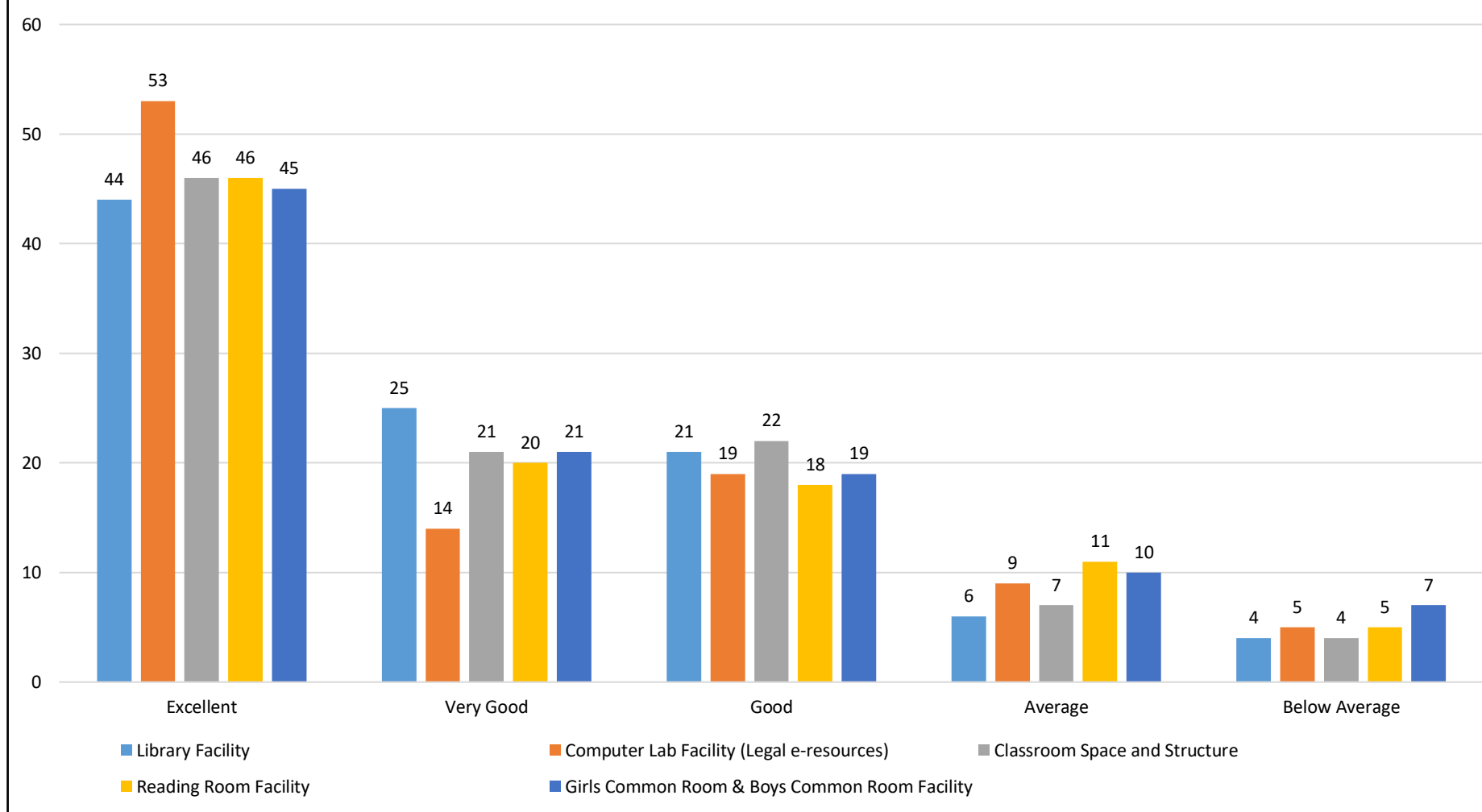
**Graph: 3: LLB Students' View about Education System**

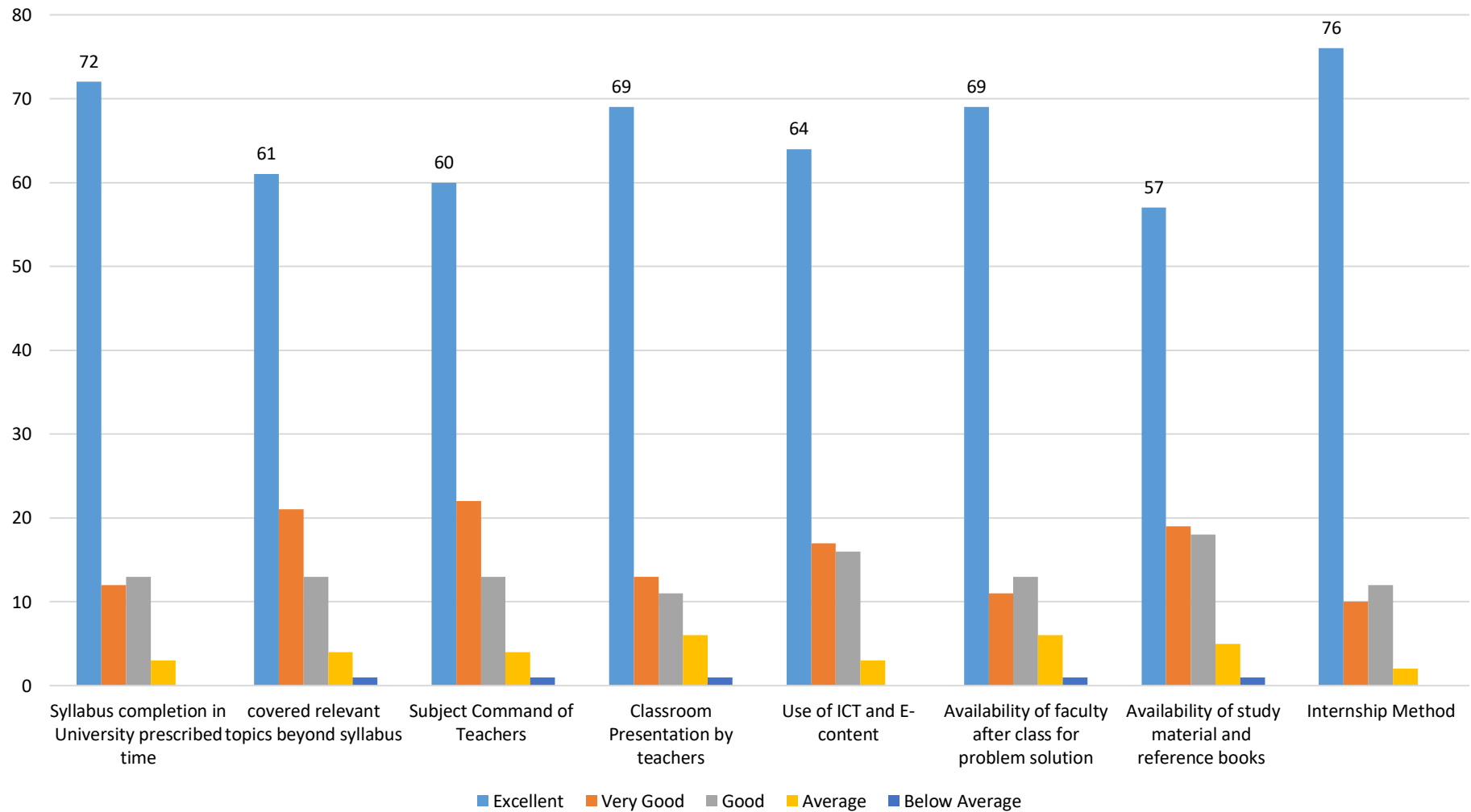
**Graph: 4: Opinion of LLB Students about Infrastructure**





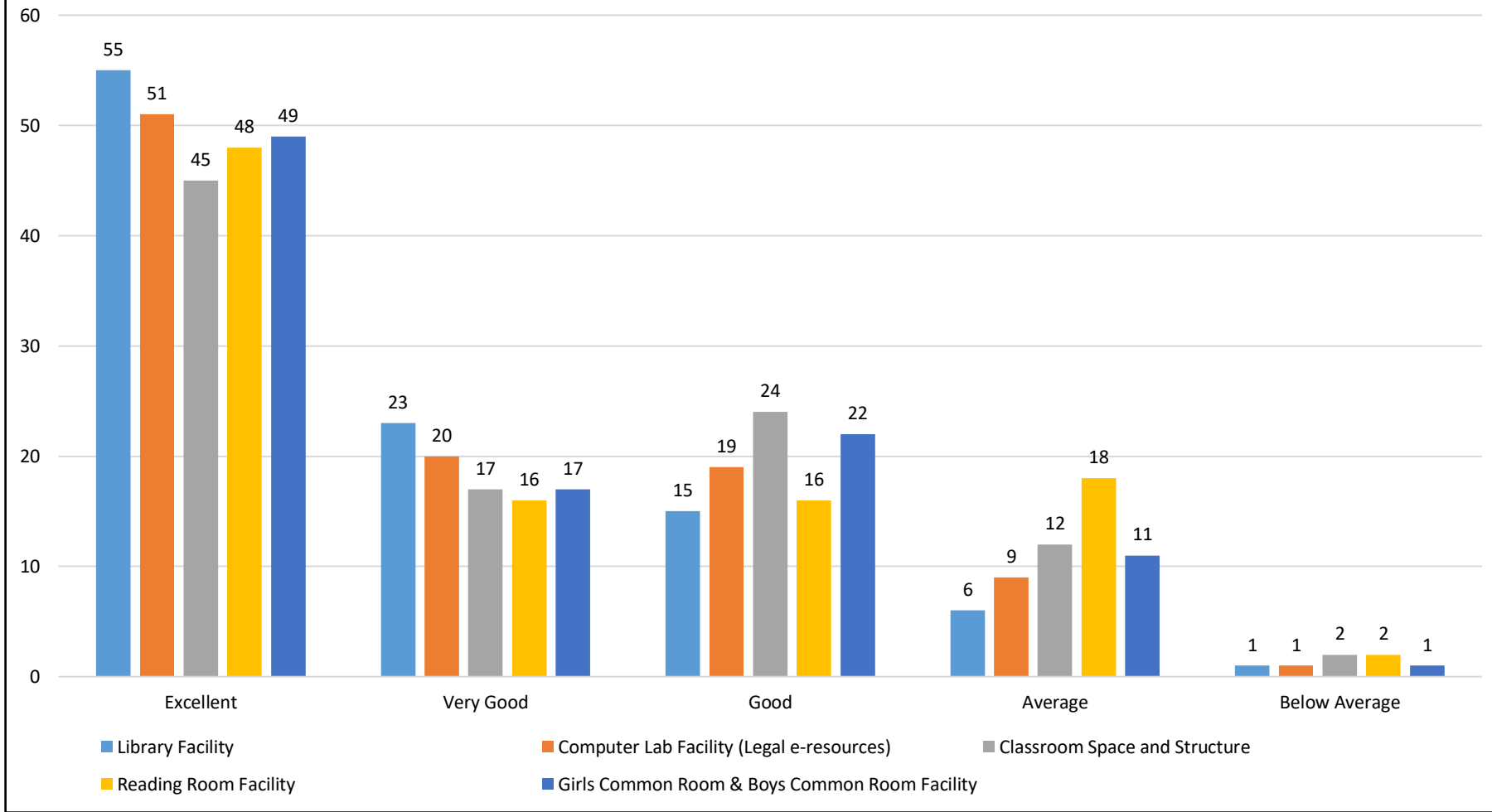

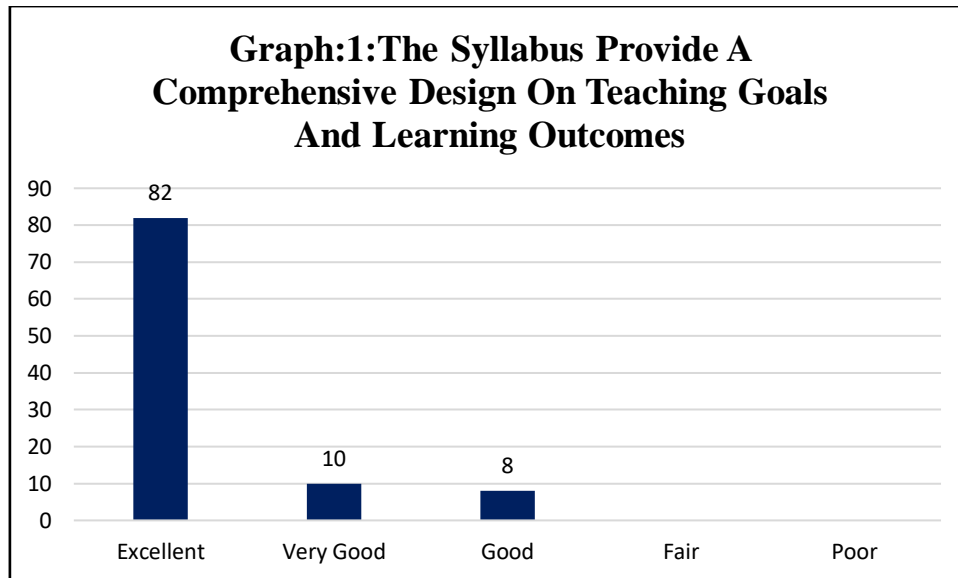

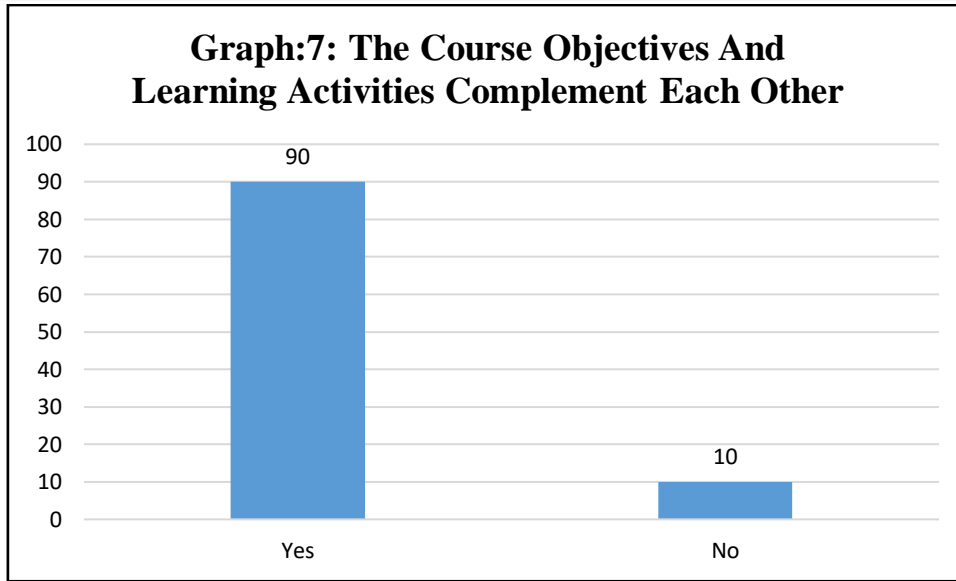

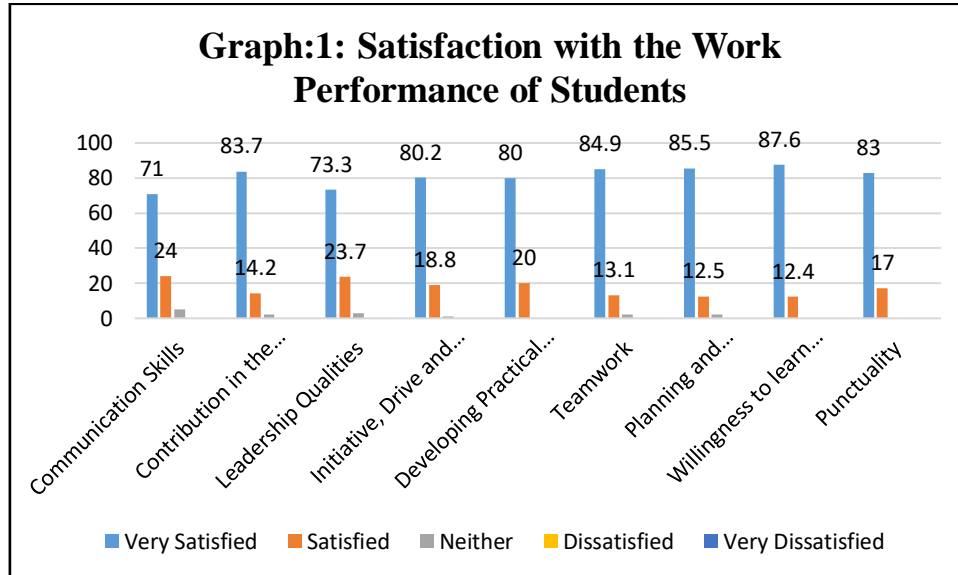

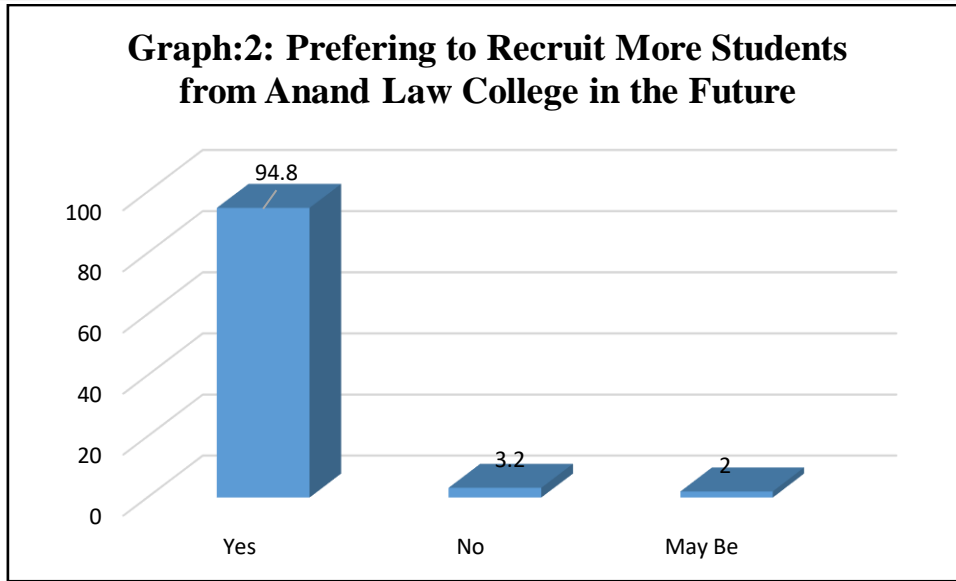

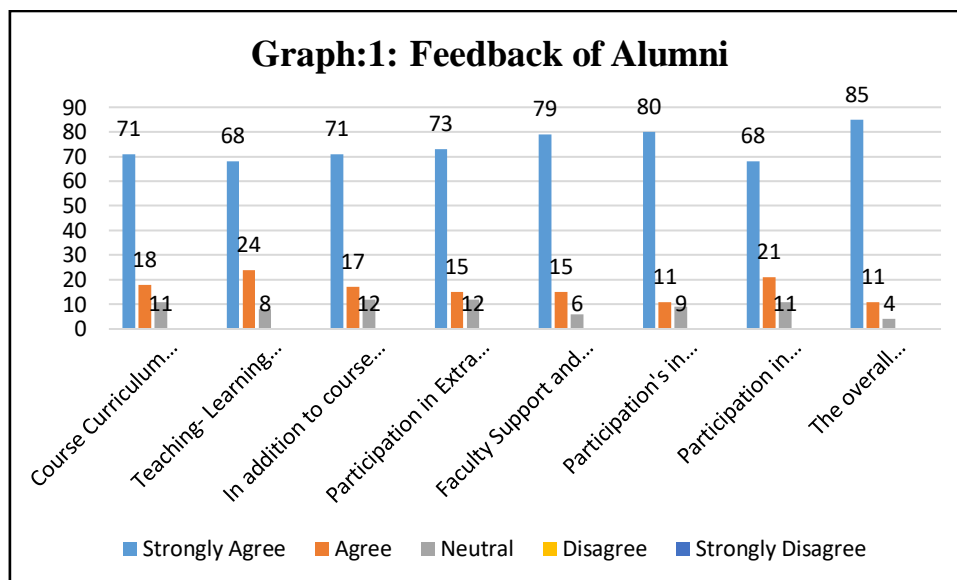
