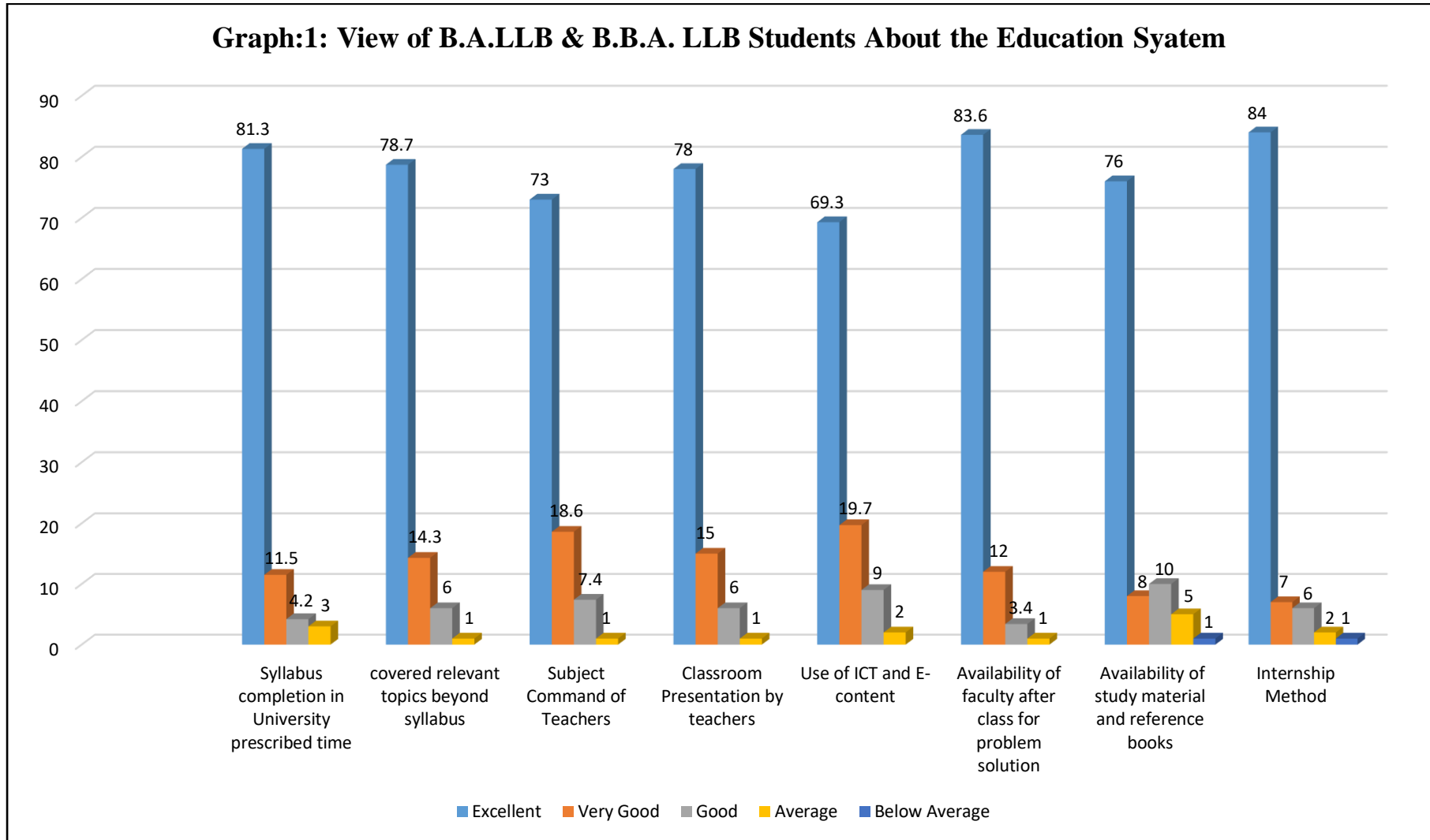

Action Taken Report

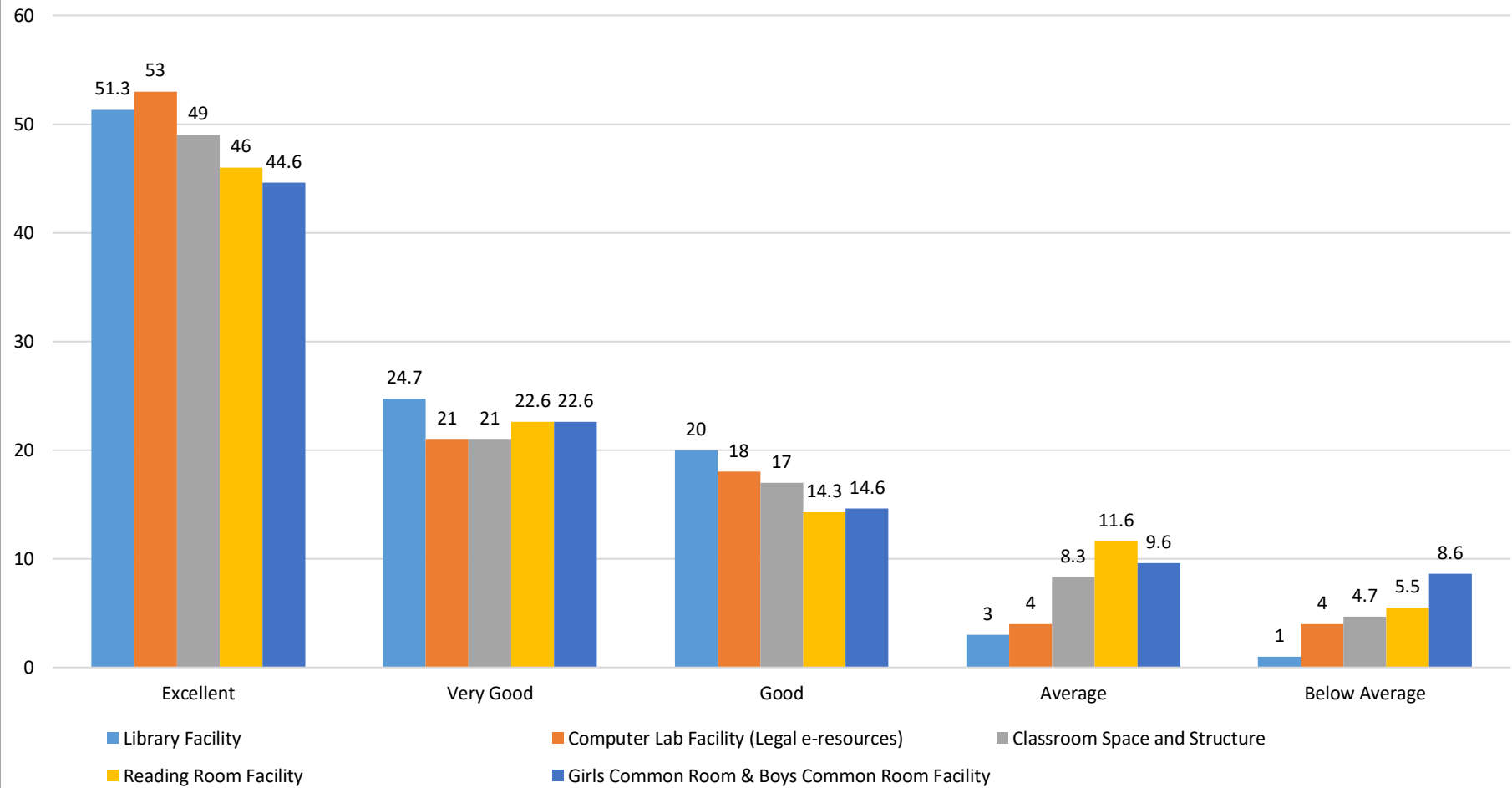
Sr. No.	Issues	Action Taken

❖ Graphical Analysis of Students' Feedback Response (Academic Year 2019-2020)



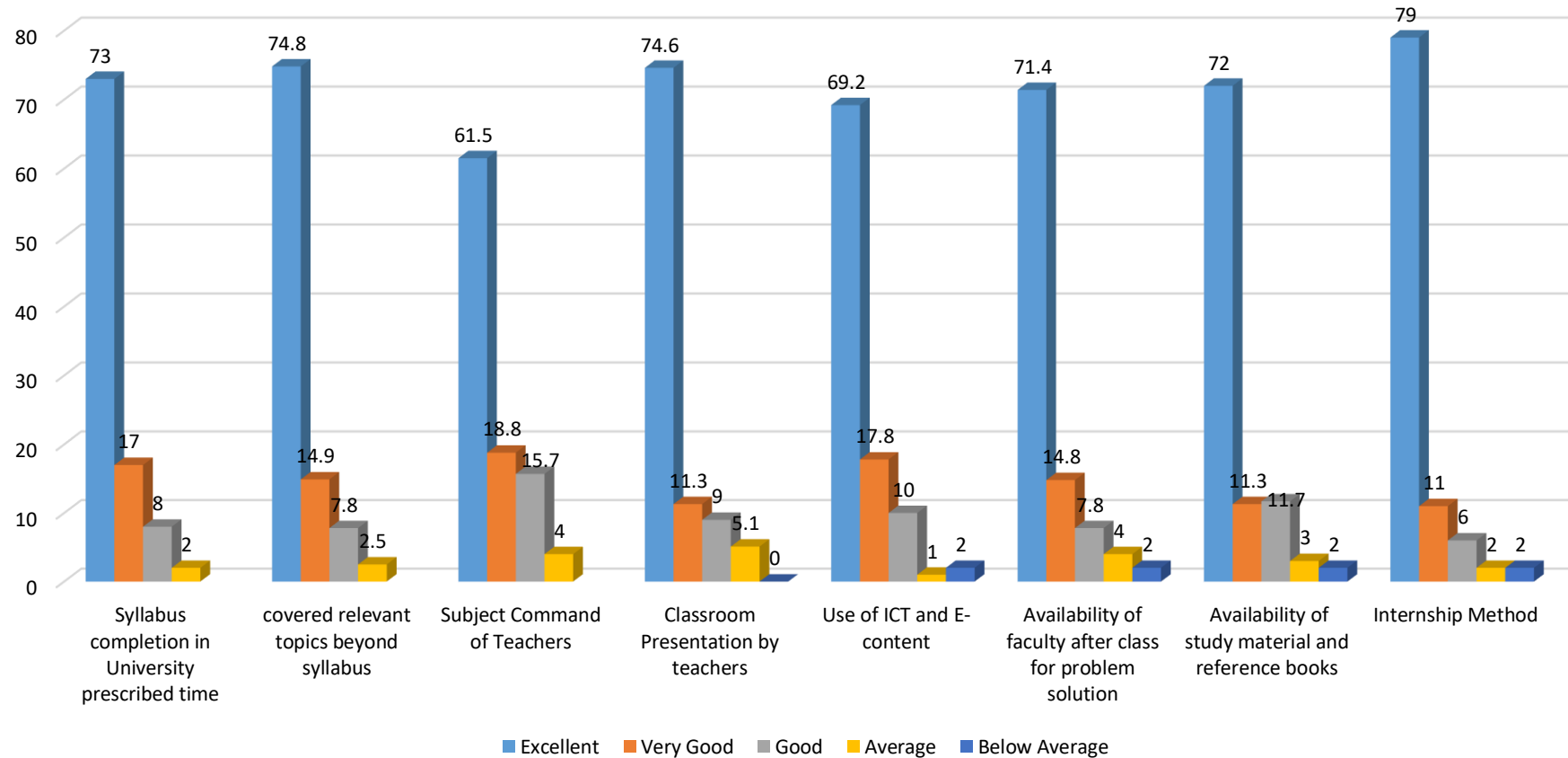

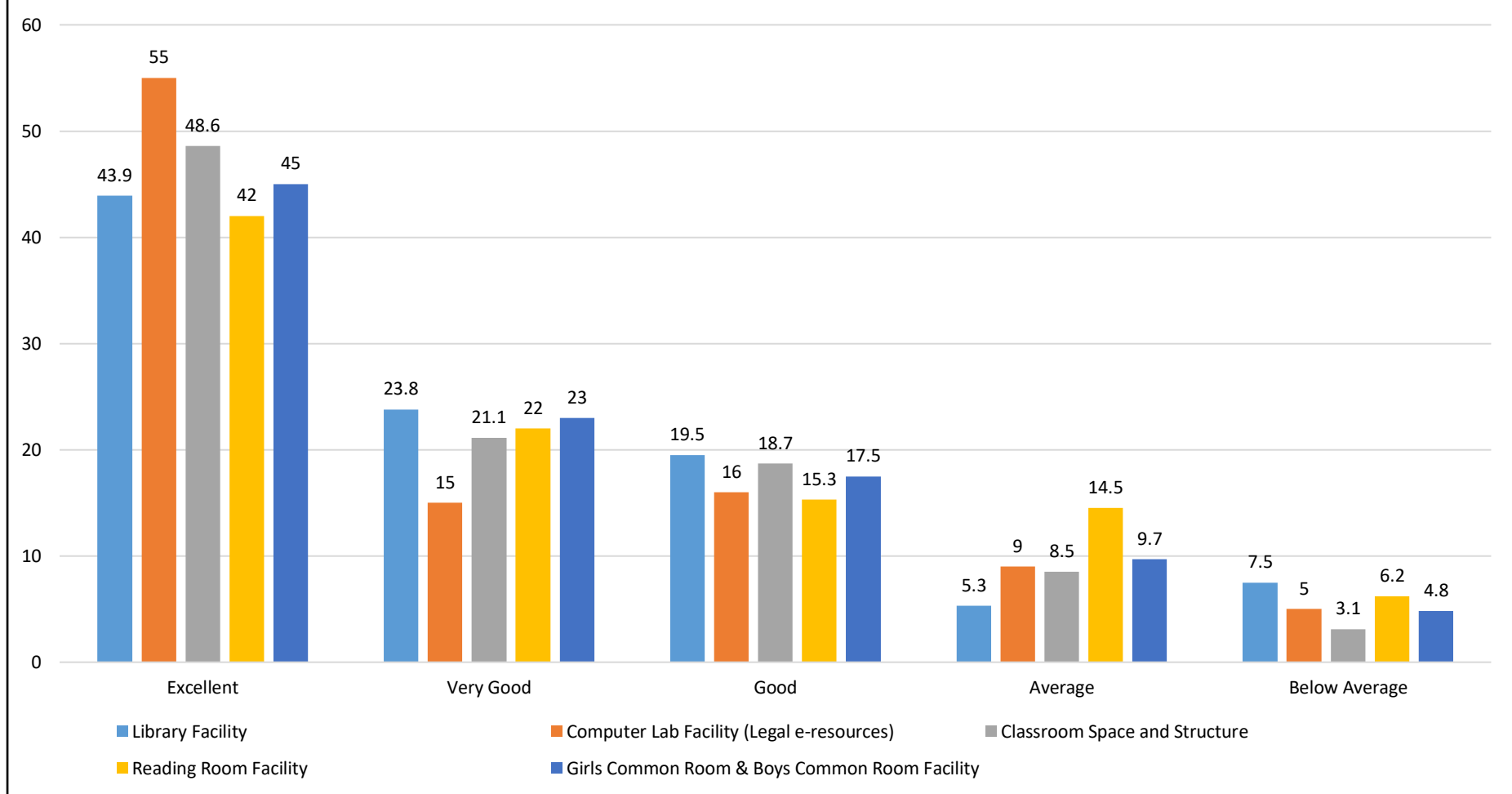
Graph:3: Opinion of LLB Students Regarding the Education System

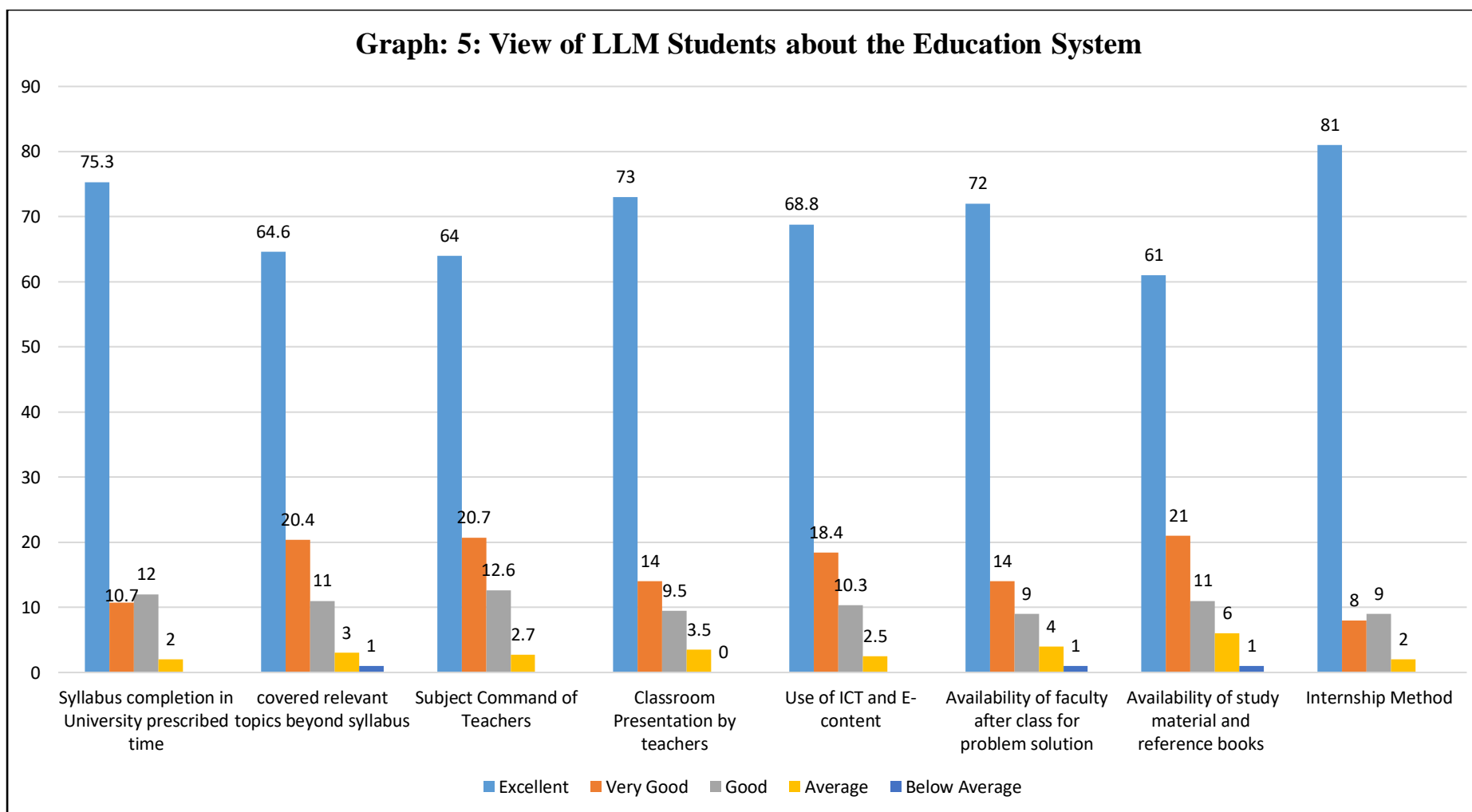

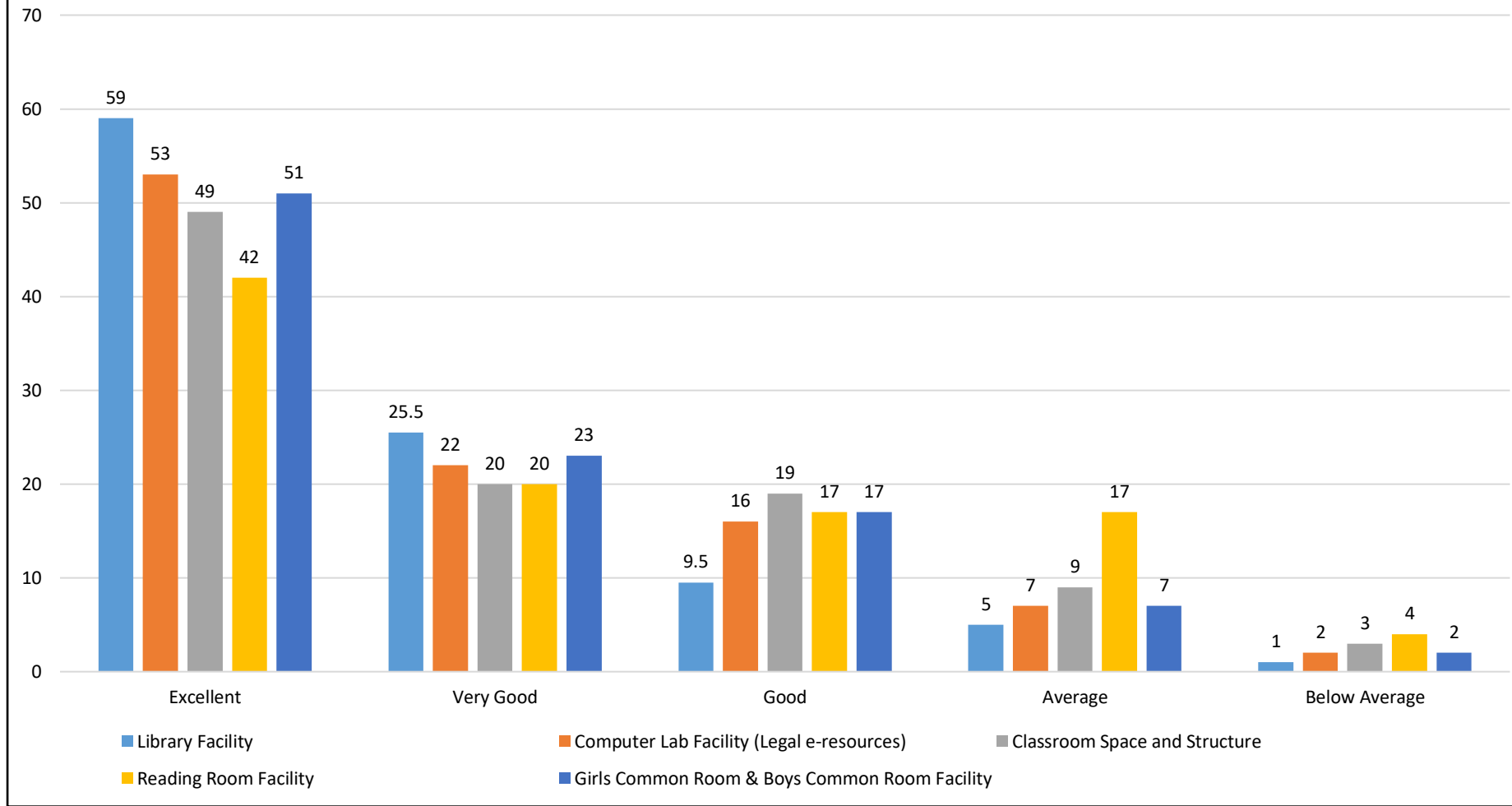
Graph: 5: View of LLM Students about the Education System

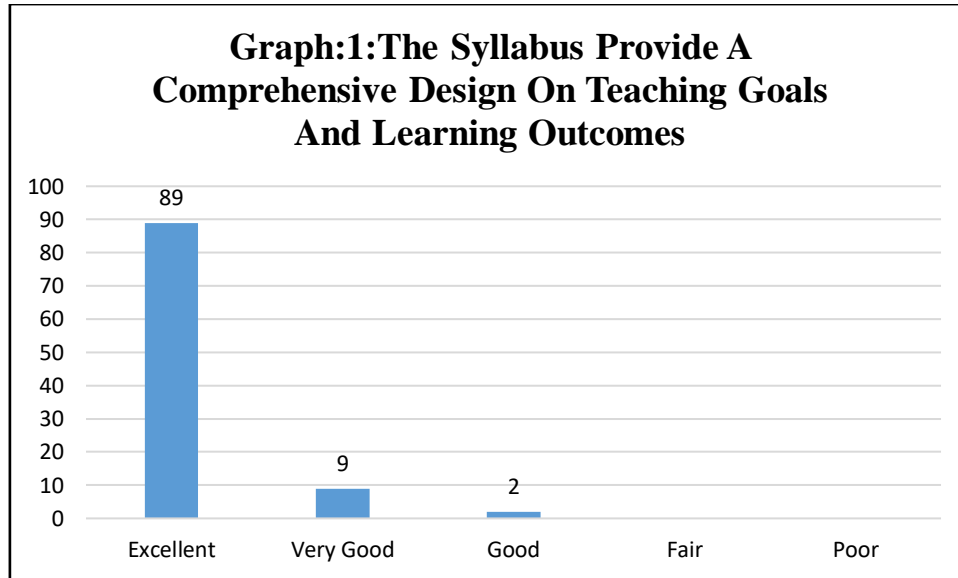

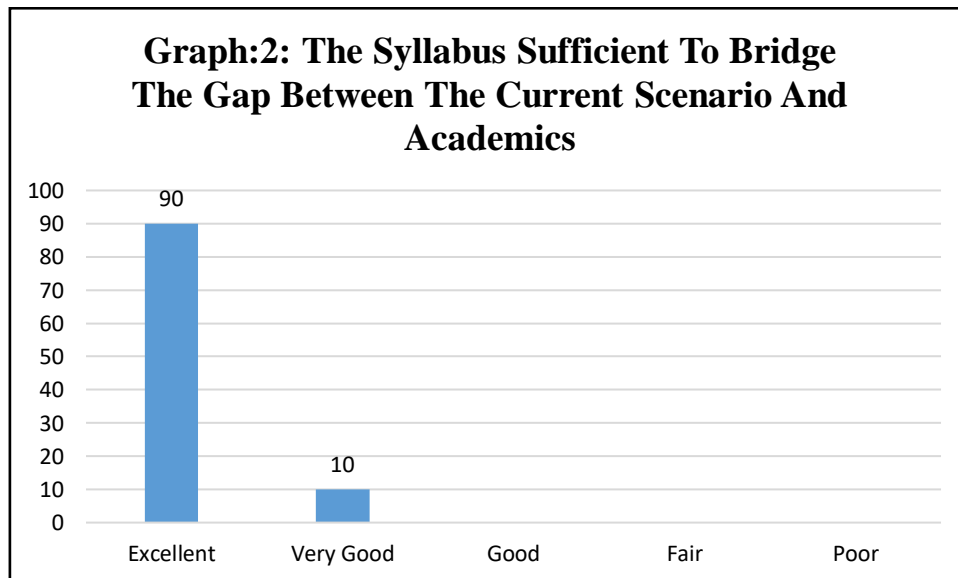

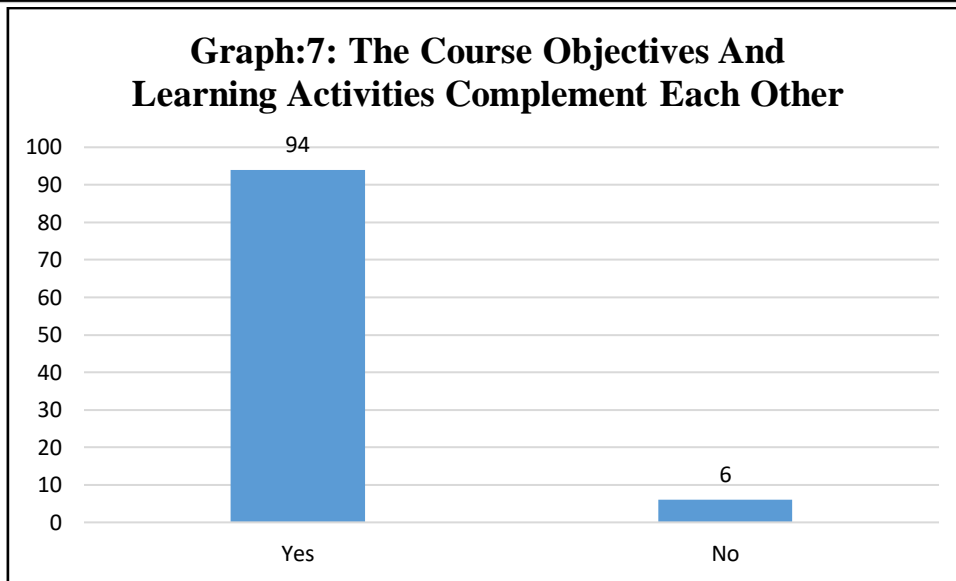

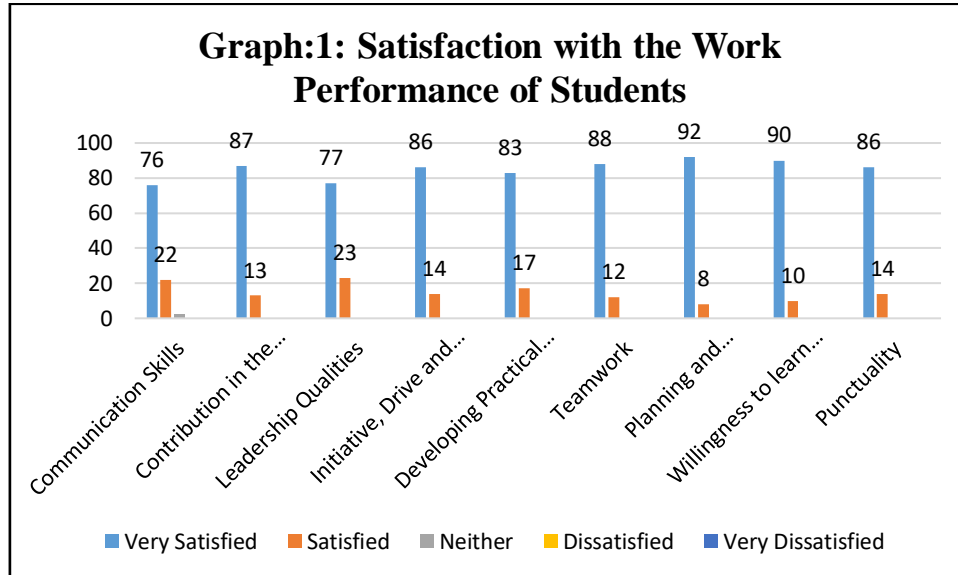

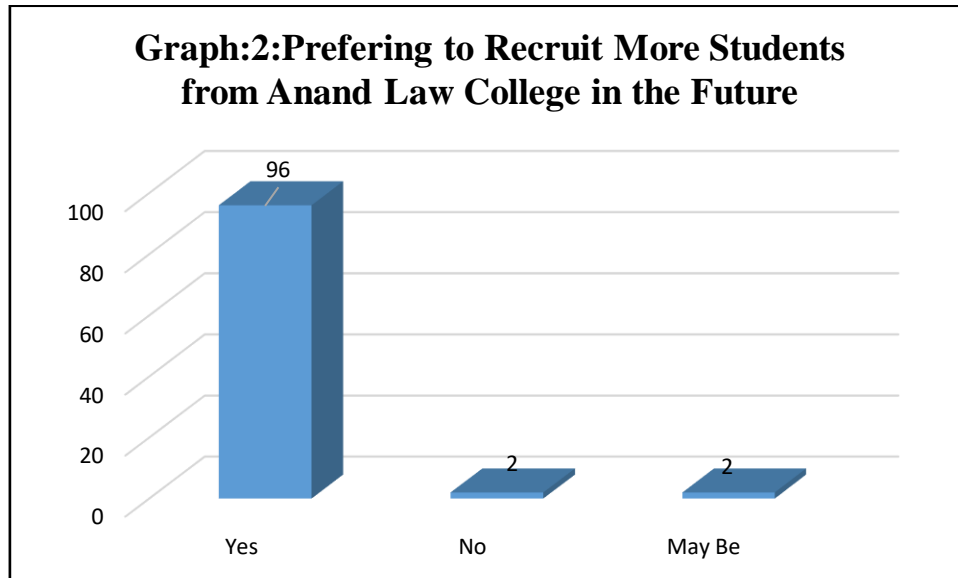
