This is to bring to your kind knowledge that the Standing Committee of the Legal Education Committee of the Bar Council of India in its meeting dated 24.5.2025 has considered the inspection report of Anand Law College, Anand submitted by the Inspection Team.

The CLE has applied for extension of approval of affiliation for imparting three year LLB degree course with intake of five sections of 60 students in each section, five year BALLB integrated degree course with intake of one section of 60 students, five year BALLB integrated degree course with intake of three sections of 60 students.

The CLE has also applied for fresh approval of affiliation for imparting 3-year LLB(H) course with intake of three sections of 60 students.

After consideration, extension of approval of affiliation has been granted to Anand Law College for imparting three year LLB degree course with intake of five sections of 60 student in each section, five year BALLB integrated degree course with intake of one section of 60 students, five year BBA LLB integrated degree course with intake of one section of 60 students and fresh approval of affiliation to Anand Law College, Anand for imparting 3-year LL.B(H) integrated with intake of one section of 60 students for the academic year 2025-26 and 2026-27 subject to the conditions as imposed by the Inspection Team of BCI and additional conditions imposed by the Standing Committee in order to ensure compliance with Rules of Legal Education 2008 and other stipulations/enumerations as per Rules of Legal Education & other guidelines/circulars issued in this regard from time to time by Bar Council of India.
