Code of Conduct for Students

All the students at the college are expected to follow the below mention norms:

- To behave politely towards the staff and exchange greetings with them.
- The students shall keep the college premises clean and use only dustbins to throw out trash.
- Any charge of misconduct by students in any manner in the campus shall amount to punishment or fine as per the decision of the management of the college.
- All the rules regarding library must be followed strictly. Mutilation or unauthorized possession of library books must be avoided.
- Noisy and unseemly behaviour and disturbing studies of fellow students must be avoided, and discipline should be maintained within the college campus.
- Usage of mobile phones or camera in the classroom and library is prohibited unless given a purposeful permission by faculty members. The fine upto Rs. 500 is payable as a punishment in case of a non- permitted use of mobile phone.
- Plagiarism in preparing assignments should be avoided.
- The students must access the information from any computer after prior permission in the college and any kind of cyber-crime is a punishable offence.
- During college events, the students must not invite the other/outside students to college premises without prior permission.

Other General & Disciplinary Rules

- Uniform is compulsory for boys and girls. Formal black shoes and white socks and tie are compulsory. Uniform should be well ironed and cleaned, Shirt should be tucked.
- No student is allowed to leave the classroom without the prior permission of the teacher or until the class is over.

- Students must avoid sitting on the steps or on the staircase. They are forbidden from loitering in verandas or in the campus at any time during the session of the college.
- Calling students out of their classrooms while the lecture is in progress is prohibited.
- In case of cancellation of a class, students shall go to the library or reading room, but not to be found anywhere else in the campus.
- Hall tickets will be issued for university annual examinations only after the students clear all the dues of that term.
- Students studying in college, if found indulging in anti-national activities contrary to the provisions of Acts and Laws enforced by Government or in any activity contrary to the rules of discipline, will be liable to be expelled from the college without any notice by the Principal of the college.
- A specific permission with application must be taken by a student, if he/she wants to remain absent for more than two days.
- As per university rules, at least 70% attendance is required in order to be eligible to appear in the college internal test and University examinations, as well.
- Internal tests conducted by the college on behalf of the University are compulsory, in case of failure to payment of term fees, a student can be detained from appearing from internal examination. The students may be fined with a penalty in order to appear for the examination in such cases.
- During examination, the students must abide by the rules and regulations/changes in the same decided by the exam coordinator and college management.
- Students must always carry College Identity card for academic as well as administrative work and shall present it whenever any authorized person from the institute ask for it.
- Any attempt or act to disfigure or mishandling of the college property shall be considered a serious offence and will be punishable.
- Smoking and chewing tobacco is banned within the premises of the college.
